The grant does not constitute a lier against such property but is repayable as stated within the five year period. Dates effective from:

Category D: Grantee(s) hereby acknowledge(s) and agree(s) by signature below that if he/she sells the house within the first ten (10) years from the date of ownership, the grant is voided and the full amount of the HIP grant will be repaid by the grantee to the Bureau of Indian Affairs. Subsequent to the first ten years, if the grantee sells the house, he/she may retain ten percent (10%) of the original grant amount per year beginning the the (11th) year with the remaining amount to be repaid to the Bureau of Indian Affairs. If the sale occurs twenty (20) years or more after the date of ownership, no repayment of any part of the grant will be due to the Bureau of Indian Affairs, as per 25 CFR Part 256.4(d) (4). The grant does not constitute a lien against such property but is repayable as stated within the twenty (20) year period. Dates effective from to ...

Successor: In the event of the death of, mental incapacity of, or abandonment of the unit by all of the persons who have executed the Agreement as Grantee, the person designated as the Successor(s) shall succeed to the Grantee's rights and responsibilities under this Agreement. The Successor(s) shall execute an assumption of the Grantee's obligations under the Agreement.
