KNOW ALL MEN BY THESE PRESENTS that should circumstances arise making it impossible for either of us to act on behalf of the other, We, **DONALD E. NOONAN** and **DONNAMAE NOONAN**, husband and wife, have made, constituted and appointed, and by these presents do make, constitute and appoint our daughter, **JEANNE M. BIRKENFELD**, our true and lawful attorney, for us and in our names, places and steads, and for our use and benefit,

to ask, demand, sue for, recover, collect and receive all such sums of money, debts, dues, accounts, legacies, bequests, interests, dividends, annuities and demands whatsoever, as are now or shall hereafter become due, owing, payable or belonging to us, and have, use and take all lawful ways and means in our names or otherwise for the recovery thereof, by attachments, arrests, distress or otherwise, and to compromise and agree for the same, and acquittances or other sufficient discharges for the same for us and in our names; to make, seal and deliver, to bargain, contract, agree for, purchase, receive and take lands, tenements, hereditaments, and accept the seizin and possession of all lands, and all deeds and other assurances in the law therefor, and to lease, let, demise, bargain, sell, remise, release, convey, mortgage and hypothecate lands, tenements and hereditaments, upon such terms and conditions, and under such covenants as she shall think fit. Also, to bargain and agree for, buy, sell, mortgage, hypothecate, and in any and every way and manner deal in and with goods, wares and merchandise, closes in action, and other property in possession or in action, and to make, do and transact all and every kind of business, of what nature and kind soever, and also for us and in our names, and as our act and deed, to sign, seal, execute, deliver and acknowledge such deeds, leases and assignments of leases, covenants, indentures, agreements, mortgages, hypothecations, bottomries, charter parties, bills of lading, bills, bonds, notes, receipts, evidences of debt, releases and satisfaction of mortgage, judgments and other debts, and such other instruments in writing of whatever kind or nature, as may be necessary or proper in the premises;

GIVING AND GRANTING unto our said attorney, full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to the execution of the powers herein granted, as fully to all intents and purposes as We might or could do if personally present, We, **DONALD E. NOONAN** and **DONNAMAE NOONAN** hereby ratifying and confirming all that our said attorney, **JEANNE M. BIRKENFELD**, shall lawfully do or cause to be done by virtue of these presents.

This Power of Attorney shall not be affected by disability of the principals, and shall otherwise continue in full force and effect until revoked by subsequent writing.

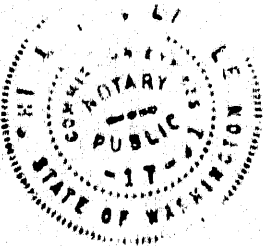
