THE POINT IS A 2-1/2 IN DIAMETER BRASS DISK STAMPED "CLARK COUNTY CONTROL POINT 41310 1992" IN CONCRETE MONUMENT WITH MONUMENT BOX AND LID 15 FEET NE FROM THE END OF A GRAVEL LOGGING ROAD AND ON THE NW EDGE OF A GRAVEL JEEP TRAIL LEADING FROM A LOG LANDING IN A CLEARCUT. IT IS SE ABOUT 700 FEET FROM THE NE CORNER OF SECTION 1 T2N R4E NEAR THE CLARK-SKAMANIA COUNTY LINE.

THE POINT IS ABOUT 9 MILES NORTHEAST OF THE CITY OF WASHOUGAL. TO REACH THE POINT FROM THE INTERSECTION OF STATE ROUTE 14 AND 6TH STREET EXIT IN WASHOUGAL:

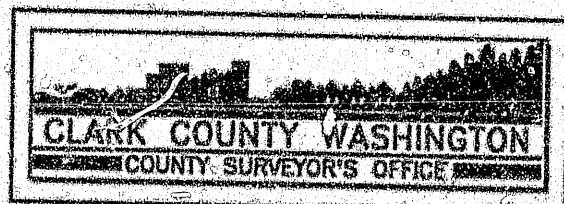
- GO NORTH ON 6TH STREET 0.5 MILES TO SE 3RD STREET,
- * WEST ON SE 3RD STREET 0.5 MILES TO THE INTERSECTION WITH SE SHEPHERD ROAD, * RIGHT (EAST) 1.0 MILES TO WASHOUGAL RIVER ROAD,
- * LEFT (NORTH) 6.5 MILES TO HUGHES ROAD
- * LEFT (NORTHEAST) ON HUGHES RD, NE 392 AVE, NE 28 ST, AND NE MILLER ROAD 2.8 MILES TO NE 39 ST.
- * RIGHT (EAST) ON 39 ST 0.1 MILES TO NE 412 AVE,
- * LEFT (NORTH) ON 412 AVE 0.75 MILES TO BRIDGE AND END OF PAVEMENT, CONTINUE ON ROAD 1200 (GRAVEL) 1.6 MILES TO FORK, TAKE LEFT FORK (ROAD 1200 WHERE SIGN SAYS 22 MILES TO YACOLT)
- * GO 1.2 MILES TO LOGGING ROAD ON LEFT (ROAD 1200 ENTERS THE TIMBER HERE FROM A CLEARCUT).
- * GO LEFT (SOUTHEAST) ON LOGGING ROAD 230 FEET TO FORK, TAKE RIGHT FORK GO 230 FEET TO THE POINT.

THERE ARE STEEL FENCE POSTS LOCATED BY REFERENCE POINTS AND MONUMENT. NOTE - FOREST ROAD NUMBERS ARE AS CALLED OUT ON WASHINGTON DEPARTMENT OF NATURAL RESOURCES MAP OF THE YACOLT BURN STATE FOREST.

 (1) For corners located at the intersection of two lines (section corners, quarter corners and sixteenth corners):

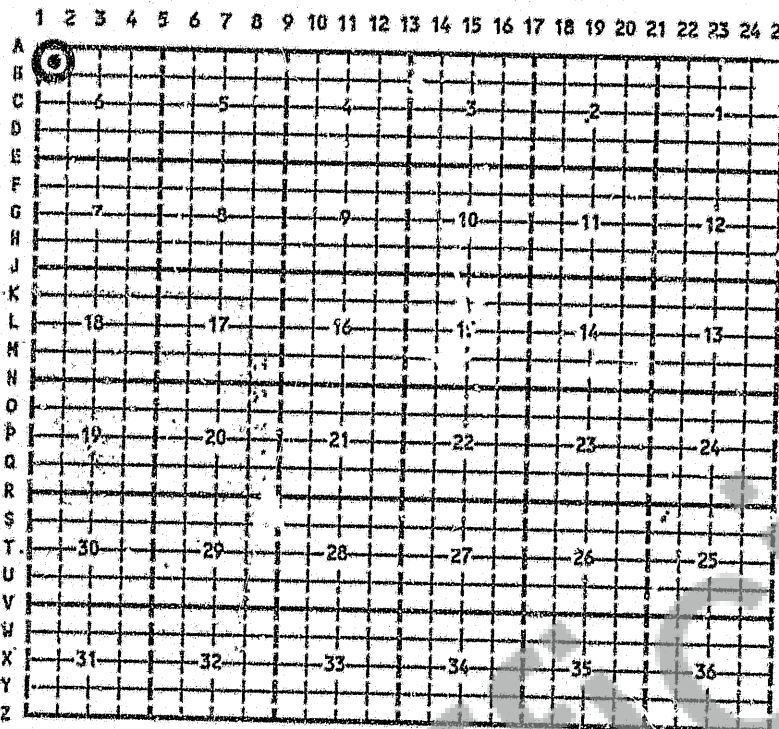
(a) The corner code is the alpha-numeric coordinate from the diagram below that corresponds to the appropriate intersection of lines.

(2) For corners that are not located at the intersection of two lines (Meander corners, DLC's, NES's, reservation boundaries, mining claims, etc.):

(a) For corners that are on one line only the corner code is the line designation and the related line segment; i.e., a corner on line 5 between "8" and "9" is designated BC-5.

(b) For corners that are between lines the corner code is both line segments; i.e., a corner in the SE1/4 of the SE1/4 of section 18 is designated MN-4-5.
