WHEREAS, the liens of the United States for said taxes have attached to certain property described as follows:

Commencing at the South Quarter Corner of Section 10, Township 3 North, Range 10 East of the Willamette Meridian, Skamania County, Washington and running thence east along the South line of said Section, 504.45 feet; thence North 00 51'09" East, 737.23 feet, more or less, to the South line of the Bonneville Power Administration right of way; thence Easterly along the South line of said right of way to a point 400 feet Westerly from the centerline of the White Salmon River; thence Southerly along a line 400 feet Westerly from the centerline of the White Salmon River to the South line of said Section 10; thence West along said South line to the point of beginning.

WHEREAS, the above described property was sold on January 29, 1988, at Skamania County Courthouse, 2nd Street (State Road #14), Stevenson, WA 98648, at public auction to satisfy a Certificate of Delinquency held by Treasurer of Skamania County.

WHEREAS, the successful bidder at this auction was Glen A. Thornton.

NOW, THEREFORE, I, the District Director of Internal Revenue Service at Seattle, Washington for and in consideration of the sum of \$1,363.00, the receipt of which is hereby acknowledged, do hereby release unto Glen A. Thornton, the right to redeem granted to the Secretary or his delegate within the period of 120 days from the date of such sale under Section 7425(d)(1) of the Internal Revenue Code of 1954, saving and reserving, however, the force and effect of the foregoing tax liens are attached, wherever situated.
