This Will made this 9th day of November, 1990 by JOHN THOMAS DAY. I am the person who affixes his signature as Testator below. I make this Will without influence from others; knowing the natural aspects of my bounty, and without influence of any medication as indicated on my medical chart.

I

I am a married man. My wife is SHIRLEY CROSS DAY. I have three children who were born to a previous marriage. They are ELLEN THERESA DAY, JOHN FRANCIS DAY, and NORA DAY LAKE.

II

I hereby revoke any Wills and Community Property Agreements heretofore made by me.

III

I hereby give to SHIRLEY CROSS DAY one-half of my community property plus any interest that she may claim in any article of personal property in which I may have a community, separate or other interest. This bequest shall include all business and casualty claim interest but shall not include any interest in the stock or assets of Tourist Facilities, Inc.

IV

I give my stock in Tourist Facilities, Inc. in equal shares to NORA DAY LAKE, PATRICK YOUNG and SHIRLEY CROSS DAY providing that if SHIRLEY CROSS DAY shall make any claim that she has any previous claim in said Corporation, she shall not participate in this grant or ownership of said stock.

It is to be remembered by all grantees of stock in Tourist Facilities, Inc. that I am indebted to Herbert Cahn in an amount in excess of \$20,000.00 and that I have pledged 60% of said stock to him to secure said loans. If Herbert Cahn gives you forbearance to use tools belonging to Tourist Facilities, Inc. and time to complete, sell or refinance the Snake River Kate, you shall pay the debt due him and return the stock. Every nut, bolt, engine, tool, fixture or item of machinery in my accumulation of same is the property of Tourist Facilities, Inc.

VI

The rest and remainder of my estate shall not be subject to distribution for three years and only then in such amounts as are needed to serve the following trust.

I give the remainder of my estate to Nora Day Lake in trust for the educational benefit of the children of John Francis Day who have been born or conceived prior to this date and to any children born or adopted by Ellen Theresa Day or Nora Day Lake. I give Nora Day Lake full discretion in her use of those funds to further the education of any of my grandchildren at any age up to their 30th year.


VII

VIII


