

NOTICE OF CHANGE OF STATUS

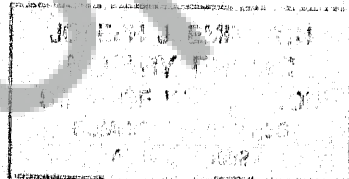

She accepts no privileges, benefits or opportunities from them, and if any such privileges, benefits or opportunities are received from any of the corporate monopolies of the above named corporate persons, it is done so Without Prejudice, RCW 62A.1-207. She is not bound by any actual or implied contract obtained by positive and/or constructive fraud, purporting to be a knowing and willing waiver of any right(s) secured by the Constitution(s) without her full knowledge and consent; including Social Security, Taxpayer Account, Employer account, driver's license, marriage license, or any other nexus with City, County, State, or Federal governments or affiliates. She has deduced from the foregoing that she is not actually or constructively a resident, citizen, subject, inhabitant, domicilee, "person" or "employer" of the District of Columbia or its affiliates, supra, as defined in the various State or Federal Revised Statutes. This Notice is made in good faith as per RCW 62A.1-203 and is to establish her place under the venue established by the Organic Law of the Union, to maintain, and to assist in retaining, the sovereignty of the posterity of "We the People" in Washington State against encroachment of the legislative municipal powers of the United States Congress, exercised by their regional agents, supra. This Notice is made for the specific purpose of asserting and preserving her rights, privileges and immunities at law and equity, including the law Merchant and the law relative to capacity to contract, principal and agent, estoppel, fraud, misrepresentation, duress, coercion, mistake, bankruptcy, the Fair Debt Collection Practices Act, and the Uniform Commercial Code, with explicit reservation of rights without prejudice, RCW 62A.1-207.
