SPECIAL POWER OF ATTORNEY
(PURCHASE/ENCUMBER)I, HARRY SMITH, hereby appoint MARTHA SMITH

as my true and lawful attorney for me and in my name and stead, and for my use and benefit to execute promissory notes, bonds, mortgages, contracts, deeds of trust and any other instruments which may be necessary or proper to purchase and/or encumber the following described real property:

Beginning at the Southeast corner of the Southwest quarter of the Northwest quarter of Section 9, Township 1 North Range 2 East of the Willamette Meridian; thence East 329.58 feet; thence South 02° 05' 43" East a distance of 74.57 feet to the center of Strunk Road; thence along the center of Strunk Road, South 87° 54' 23" West a distance of 230.00 feet to the true point of beginning; thence North 02° 05' 43" East a distance of 314.00 feet; thence West a distance of 140 feet; thence North 43° 02' 09" West to the South boundary of Mt.
