

SATISFACTION OF MARITAL LIEN

Pursuant to RCW 4.56.100, lienholder authorizes and directs the Auditor of Skamania County, State of Washington, to discharge of record the above-described lien.

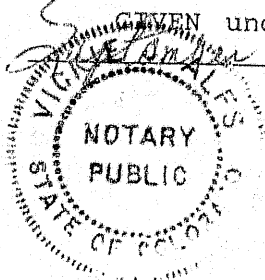
