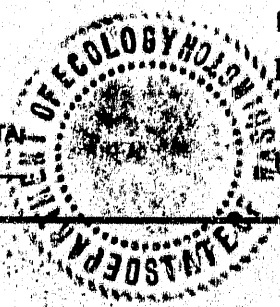
This certificate of water right is specifically subject to relinquishment for nonuse of water as provided in RCW 90.14.160.
