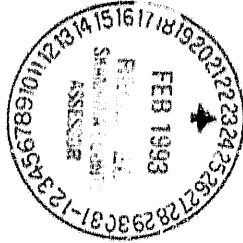
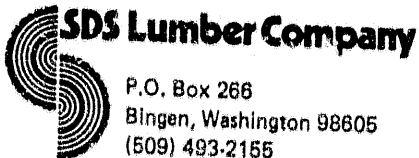


SDS Co. wishes to request a change in tax classification on the following parcels:
