A review of our records shows that many requests have not been renewed yearly, as required. Additionally, one of the permit stipulations requires the permittee to maintain the area in certain conditions as part of the agreement between the county and the permittee.

In order to update our records, an application is enclosed. Please note that the permit will be good until April, 1994, where upon a new permit will be required for the 94 spraying season. For those people who get a permit, but fail to maintain the right-of-way as agreed upon, the shoulders will be sprayed.
