Commencing at the Northeast Corner of said Southwest Quarter of the Southeast Quarter of said Section 22; thence South 00 degree 33' 58" West along the East line of said Southwest Quarter of the Southeast Quarter, 189.00 feet to the True Point of Beginning of this description; thence continuing along said East line South 00 degrees 33' 58" West 480.96 feet; thence leaving said line due West 330.90 feet to a point on the centerline of a county road known and designated as the Kelly-Henke Road; thence North 34 degrees 54' 08" East 238.00 feet; thence North 13 degrees 33' 00" East 211.84 feet; thence North 19 degrees 11' 42" East 84.50 feet; thence leaving said line due East 122.06 feet to the Point of Beginning and terminus of this description.
