That portion of the Southwest Quarter of the Northeast Quarter of Section 1, Township 3 North, Range 7 1/2 East of the Willamette Meridian, in the County of Skamania, State of Washington, lying Northeasterly of the Northeasterly line of that certain strip of land 150 feet in width acquired by the State of Washington for secondary State Highway 8-C, by deed dated October 16, 1956, and recorded at Page 483 of Book 42 of Deeds and as more particularly described at Pages 6 and 7 of Book A of Highway Plats, records of Skamania County, Washington;
