Parcel II

That portion of the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 36, T. 3 N., R. 7 E.W.M., in Skamania County, Washington, described as follows:

BEGINNING at the NE corner of Lot 11, IMAN ROCK CREEK TRACTS, according to the plat thereof, recorded in Volume "A" of Plats, page 118, records of Skamania County, Washington, said point being 20 feet south of the South Bank of Rock Creek; thence easterly, parallel with and 20 feet southerly from said south bank, 70 feet; thence north, parallel with the west line of said NW $\frac{1}{4}$ SW $\frac{1}{4}$, 116 feet; thence west parallel with the north line of said Lot 11, a distance of 165 feet to the west line of said NW $\frac{1}{4}$ SW $\frac{1}{4}$; thence south, along said west line and along the most northerly east line of Lot 10 of said IMAN ROCK CREEK TRACTS, 131 feet to an inner corner of said Lot 10; thence easterly, along the north line of said Lots 10 and 11, a distance of 110 feet to the point of beginning. Also Lots 10 and 11 of Iman Rock Creek Tracts.

SUBJECT TO walling easement four feet in width, the centerline of which is described as follows, to-wit:

BEGINNING at the SE corner of Lot 11, IMAN ROCK CREEK TRACTS, according to the plat thereof, recorded in Volume "A" of Plats, page 118, records of Skamania County, Washington, thence west, along the south line of said Lot 11, a distance of two feet to the true point of beginning of centerline, thence northerly, parallel with the east line of said Lot 11, to the north line of said Lot 11, thence continuing north 2 feet; thence easterly, parallel with and 18 feet south of the South Bank of Rock Creek, 72 feet to the terminus of said centerline.
