

NOTORIOUS DECLARATION APOLOGY AND RETRACTION

During my 52 years of living I have entered into numerous adhesion contracts involving such subjects as drivers licenses, mortgages, Social Security and Selective Service agreements. I cannot remember all of the contracts to which I am or have been a party. Many of the adhesion contracts I entered had clauses requiring that I declare my Date of Birth under penalty of false swearing and/or penalties of fraud.

Only very recently have I discovered that I do not now have, nor have I ever had, a Date of Birth. In every instance in which I declared "my" Date of Birth, I innocently, inadvertently, unknowingly, and without evil intent declared a falsehood. I now retract all such declarations of birthdates.

Legal definitions, and not vague street language, rule the construction and validity of contracts. The legal definition of "Date" published in Black's Law Dictionary (Fifth Edition), is: "The specification in a written instrument of the time (day, month, and year) when it was made (executed)". Black's defines "birth" to mean, "The act of being wholly brought into separate existence". The foregoing definition of "birth" describes an artificial person, created and wholly brought into separate existence. It describes a birth certificate, the subject of which is, in the matter at issue, the same name as my own. "Executed" means "Completed; carried into full effect; signed; now in existence". The Date of Birth of that artificial entity, i.e. the date on which the written instrument was executed and the name wholly brought into existence separate from the Common Law name of the Declarant, is August 5, 1941. It was on that date that the Common Law name, Walter Daniel Saunders, was appropriated and established as the legal property of a state, by a registrar's act of receiving/signing/filing/recording the certificate.

I am a natural, flesh, blood, soul and Spirit human being. I am not a written instrument. I am not an artificial person. The day I was born was August 5, 1941. The Notification of Birth Registration came to be executed later on August 5, 1941, a separate event. The artificial entity thereby "wholly brought into separate existence" has a Date of Birth, or Birthdate. I do not have a Date of Birth or Birthdate. I have a birthday.

I sincerely regret any loss, injury or inconvenience I may have inflicted on any person by reason of my ignorance regarding the Date of Birth, and plead forgiveness for my trespasses and exonerate for any crimes I may have inadvertently committed.
