DURABLE POWER OF ATTORNEY

- I, S. A. NICKELSON, also known as SCNDRA ANN NICKELSON, the principal of Portland, Oregon, hereby designate Christopher D. Bach of Bellingham, Washington, my attorney in fact and agent (subsequently called my agent), in my name and for my benefit:
- 1. General Grant Power of Attorney. To exercise or perform any act, power, duty, right or obligation whatsoever that I now have or may hereinafter acquire relating to any property, real or personal, tangible or intangible, now owned or hereafter acquired by me, including, without limitation, the following specifically enumerated powers. I grant to my agent full power and authority to do everything necessary in exercising any of the powers herein granted as fully as I might or could do if personally present, with full power of substitution or revocation, hereby ratifying and confirming all that my agent shall lawfully do or cause to be done by virtue of this power of attorney and the powers herein granted.
- A. Power of Collection and Payment. To forgive, request, demand, sue for, recover, collect, receive, hold all such sums of money, debts, dues, commercial paper, checks, drafts, accounts, deposits, annuities, pensions, profit sharing retirement, social security insurance and other contractual benefits and proceeds, all documents of title, all property, real or personal, tangible or intangible property rights and demands whatsoever, liquidated or unliquidated, now or hereafter owned by or due, owing, payable or belonging to me, or in which I have or may hereafter acquire an interest; to have use and take all lawful means and equitable and legal remedies and proceeding in my name for the collection and recovery thereof, and to execute and deliver for me, on my behalf and in my name, all endorsements, releases, receipts or other sufficient discharges for the same;
- B. Power to Acquire and Sell. To acquire, purchase, exchange, grant options to sell and convey real or personal property, Langible or intangible, or interests therein, on such terms and conditions as my agent shall deem proper;
- C. Management Powers. To maintain, repair, improve, invest, manage, insure, rent, lease, encumber and in any manner deal with any real or personal property, tangible or intangible, or any interest therein, that I now own or may hereinafter acquire, in my name and for my benefit, upon such terms and conditions as my agent shall deem proper;

- D. Banking Powers. To make, receive and endorse checks and drafts, deposit and withdraw funds, acquire and redeem associations and other in-titutions, execute or lease such necessary or proper in the exercise of the rights and powers herein grant;
- E. Motor Vehicles. To apply for a Certificate of Title upon, and endorse and transfer title thereto, for any vehicle, truck, pickup, van, motorcycle or other motor the title to said motor vehicle is free and clear of all in such transfer assignment that liens and encumbrances except those specifically set forth
- P. Business Interest. To conduct or participate in any lawful business of whatever nature for me and in my name; execute partnership agreements and amendments thereto incorporate, reorganize, merge, consolidate, recapitalize, sell, liquidate or dissolve any business; elect or employ officers, directors and agents; carry out the provisions of any agreement for the sale of any business interest or the stock therein; and exercise voting rights with respect to options;
- separate income tax returns or declarations of estimated tax returns with respect to gifts made by me for any year or splitting provisions or other tax election; and to prepare, sign and film any claims for refund of any tax;
- times to any safe deposit box rented by me, wheresoever located, and to remove all or any part of the contents box, and any institution in which any such safe deposit box estate as a result of permitting my agent to exercise this

- Interpretation and Government Law. This instrument is to be construed and interpreted as a general durable power of attorney. The enumeration of specialic powers herein is not intended to, nor does it, limit or restrict the general power herein granted to my agent. executed and delivered in the above named State, and the Phis instrument is laws of said state shall govern all questions as to the validity of this power and construction of its provisions.
- Third-Party Reliance. Third parties may rely upon the representations of my agents as to all matters, to any power granted to my agent, and no person who may act in reliance upon the representation of my agent, or the authority granted to my agent, shall incur any liability to me or my estate as a result of permitting my agent to exercise any power.
- Disability of Principal. This General Power of Attorney shall not be affected by my subsequent disability
