ROBERT PLANT, dba Cross Wind Logging, Claimant,

vs.

GLOBAL PACIFIC FOREST PRODUCTS, INC., a Washington corporation.

Notice is hereby given that Robert Plant, dba Cross Wind Logging of Multnomah County, State of Oregon, claims a lien upon felled logs being about 40 loads in quantity, which were cut in Clark County, State of Washington, marked with the Global Pacific Forest Products brand designated as GF7, and are now lying, in part, on that certain tract of land commonly referred to as Steve Corwin Property, Section 23, Township 3, Range 8E, Skamania County, Washington for labor performed upon and assistance rendered in harvesting the said timber by felling, bucking, yarding, loading and/or shipping timber; that the name of the owner or reputed owner of the property is Steve Corwin; that Global Pacific Forest Products, Steve Corwin's agent, employed said Robert Plant to perform such labor and render such assistance upon the following terms and conditions, to wit:

The said Global Pacific Forest Products agreed to pay the said Robert Plant for such labor and assistance the sum of \$21 per ton of timber cut, bucked, yarded and loaded as determined by the scale slips in accordance with that certain Subcontractors Agreement entered into by and between the parties and attached hereto as Exhibit A and by this reference incorporated herein. Said contract has been faithfully performed and fully complied with on the part of said Robert Plant, who performed labor upon and assisted in harvesting the timber as agreed; that said labor and assistance were so performed and rendered upon the said Steve Corwin Property between the 18th day of November and the 28th day of December, 1993; and the rendering of said service was closed on the 28th day of December, 1993, and 60 days have not elapsed since that time; that the amount of claimant's demand for said service is \$21,000.00; that no part thereof has been paid; and there is now due and remaining unpaid thereon after deducting all just credits and offsets, the sum of \$21,000.00 in which amount Robert Plant claims a lien upon the said Steve Corwin Property, and the logs and timber thereon. The said Robert Plant also claims a lien on all said cutting contracts, logs, lumber and timber now owned by or under contract to said Global Pacific Forest Products to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.



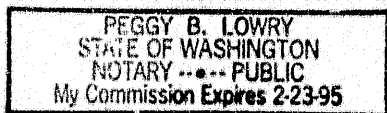
