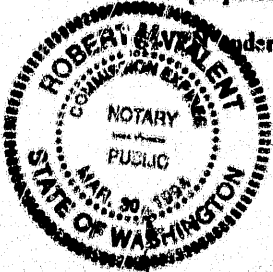

CENTERLINE DESCRIPTION

State Highway #14

Beginning at the southwest corner of Section 29, Township 3 North, Range 8 East W.M. in Skamania County, Washington, thence N38°07'36"E 1387.41 feet to P.C. Station 201+11.4 back and 205+65.1 ahead, being the P.C. of a 955.0 foot radius curve to the right; thence following said curve through a central angle of 29°04'00" 484.4 feet; thence N83°17'00"E 202.6 feet to P.C. Station 212+52.21, being the P.C. of a 1910.0 foot radius curve to the left; thence following said curve through a central angle of 11°35'00" 386.1 feet; thence N71°42'00"E 11.8 feet to Station 216+50.0, said point being N53°58'33"E 2339.53 feet from the southwest corner of Section 29, Township 3 North, Range 8 East W.M. in Skamania County, Washington.

Wind River Road

Beginning at grade intersection State Highway #14 Station 212+13.5 P.O.T. equals Wind River Road Station 10+00 P.C., thence following a 573 foot radius curve to the left through a central angle of 32°32'00" 325.36 feet to Station 13+25.36 P.T., thence N50°45'00"E 174.64 feet to Station 15+00 P.O.T..

PARCEL DESCRIPTION

A strip of land lying to the left of the above described centerlines and being 60 feet in width at State Highway #14 Station 209+50; thence tapering to 100 feet in width at State Highway #14 Station 210+50; thence tapering to 110 feet in width at State Highway #14 Station 211+00; thence tapering to 85 feet in width at State Highway #14 Station 212+00; thence tapering to 40 feet in width at Wind River Road Station 13+50.

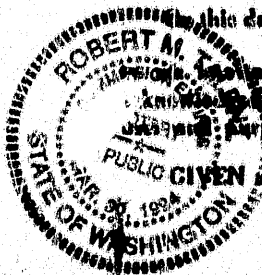
