2. For plaintiff's costs and disbursements in the amount of \$57.83 and for plaintiff's attorney's fees in the amount of \$550.00.

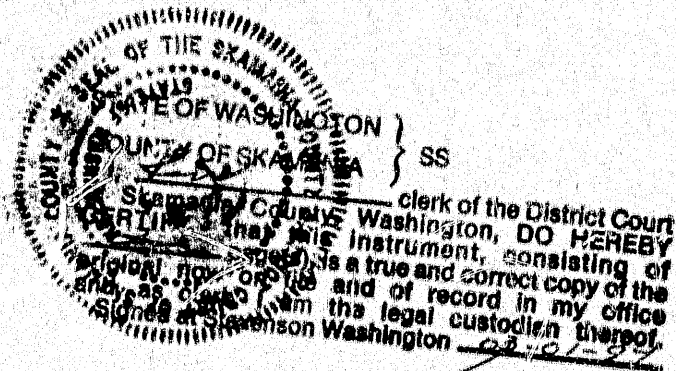
3. This judgment (pursuant to RCW 4.56.110) shall bear interest at the rate of 12% per annum from date of entry until paid.
