the appointment of a receiver or conservator with respect to the business of the attorney-in-fact, or



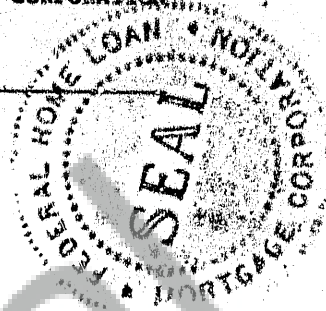

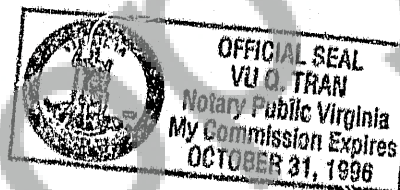
