Commencing at a point 208.7 feet south of the northeast corner of Section 19, T. 1 N., R. 5 E. W.M., Skamania County, Washington; thence west 626.1 feet; thence north 208.7 feet to the north line of said Section 19; thence west along the north line of said Section 19 a distance of 1133.9 feet; thence south to the north line of State Highway 14; thence easterly along said north line to the east line of said Section 19; thence north along said east line to the point of beginning.

This certificate of water right is specifically subject to relinquishment for nonuse of water as provided in RCW 90.14.180.
