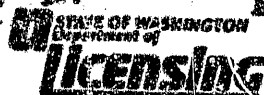

EXHIBIT "A"

PARCEL 1

A tract of land the northwest Quarter of the northeast Quarter of Section 28, Township 3 North, Range 8 East of the Willamette Meridian, in the County of Skamania, State of Washington described as follows:

Beginning at a point 682 feet West and 30 feet South of the northeast corner of the Northwest quarter of the Northeast Quarter of said Section 30; thence west 156 feet; thence South 264 feet; thence East 156 feet; thence North 254 feet to the place of beginning.

PARCEL 2

A parcel of land located in the northwest Quarter of the Northeast Quarter of the northwest Quarter of Section 28, Township 3 North, range 8 East of the Willamette meridian, Skamania County, Washington described as commencing at a point 682 feet West and 294 feet South of the Northeast corner of the Northwest Quarter of said Section 28 and running thence West 156 feet; thence South 139.06 feet; thence East 156 feet to the West line of Payroll Road; thence North along said West line 139.06 feet to the Point of Beginning.
