A tract of land in the Southeast quarter of the Southeast quarter of Section 27, Township 3 North, Range 8 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at the Northwest corner of Lot 2 of the Thelma Tombleson Short Plat as recorded in Book 3 of Short Plats, Page 111; thence North $88^{\circ} 07' 04''$ West 104 feet to the West line of a tract of land conveyed to Mitchell C. Creon Et Ux, by instrument recorded October 9, 1990 in Book 120, Page 910; thence South along said West line 174.28 feet, more or less, to the Southwest corner of said tract; thence East along the South line to the Southeast corner of the Creon Tract; thence North along the East line of said tract 174.28 feet, more or less, to the Point of Beginning.
