1 3.3 PROPERTY TO BE AWARDED TO THE WIFE.

2 [X] The wife is awarded as her separate property the property set forth in Exhibit
3 "A". This exhibit is attached or filed and incorporated by reference as part
of this decree.

4 3.4 LIABILITIES TO BE PAID BY THE HUSBAND.

5 The parties are responsible for a mortgage, which encumbers the real property set
6 forth on Exhibits "B" and "C". The husband has assumed responsibility for payments
7 on this mortgage. The husband is under the further obligation, pursuant to contract,
8 to refinance this mortgage. The husband shall assume said mortgage, and hold the
9 wife harmless from any responsibility therefor. Upon refinancing the mortgage, the
10 husband shall obtain clear title to the property awarded to the wife, as set forth
11 herein. Should the husband default on this debt, the wife shall have the right to take
12 possession of the real property awarded to the husband herein and to sell it. The
13 husband shall sign any documents necessary to effectuate said sale. From the
14 proceeds of said sale, the wife shall be reimbursed for any expenses she has incurred,
15 including, but not limited to, payments to bring the debt current, any penalties, any
16 attorney's fees incurred, all costs of sale, and payment of the marital lien set forth
below. The balance of the sale proceeds shall go to the husband.

12 The husband shall be responsible for any debts owed by any business interest
awarded to him herein.

13 The husband shall further be responsible for any debts in his name only.

14 The husband shall be responsible for all liabilities incurred by him since the date of
15 separation.

16 3.5 LIABILITIES TO BE PAID BY THE WIFE.

17 The wife shall be responsible for any debts owed by any business interest awarded
18 to her herein.

19 The wife shall further be responsible for any debts in her name only.

20 The wife shall be responsible for all liabilities incurred by her since the date of
21 separation.

22 3.6 HOLD HARMLESS PROVISION.

23 [X] Each party shall hold the other party harmless from any collection action
24 relating to separate or community liabilities set forth above, including
25 reasonable attorney's fees and costs incurred in defending against any attempts

17 reduced by \$38,589.00 to \$35,978.00, in return for the husband assuming the
18 wife's share of the mortgage on the parties real property, as set forth above.
19 The wife shall be granted a marital lien in this amount, which shall be secured
20 with a Deed of Trust against the husband's real property, as set forth on
21 Exhibit "A". Said lien shall accrue interest at the rate of twelve percent (12%)
22 per annum until paid, and shall be due within five years of the date of entry
23 of the Decree of Dissolution of Marriage herein, or upon sale of the property,
24 whichever occurs first.

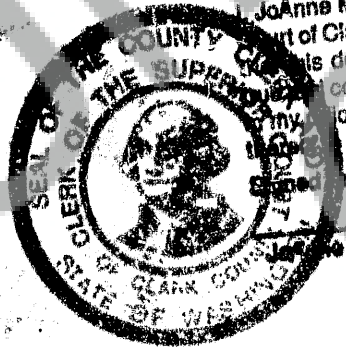
