GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That Helen E. Ogle

has made, constituted and appointed, and by these presents does make, constitute and appoint Merle Milton Ogle true and lawful attorney for her and in her name, place and stead and for her use and benefit Merle Milton Ogle

to ask, demand, sue for, recover, collect and receive all such sums of money, debts, dues, accounts, legacies, bequests, interests, dividends, annuities and demands whatsoever, as are now or shall hereafter become due, owing, payable or belonging to Helen E. Ogle and have, use and take all lawful ways and means in her name, or otherwise, for the recovery thereof, by attachments, arrest, distress or otherwise, and to compromise and agree for the same, and to make, sign, seal and deliver acquittances, or other sufficient discharges for the same; for Helen E. Ogle and in her name, to bargain, contract, agree for, purchase, receive and take lands, tenements, hereditaments, and accept the seizin and possession of all lands, and all deeds, and other assurances in the law therefor; and to lease, let, demise, bargain, sell, remise, release, convey, mortgage and hypothecate lands, tenements and hereditaments, upon such terms and conditions and under such covenants as Merle Milton Ogle shall think fit; to assign and transfer any note or mortgage; to dedicate any street, avenue, alley, place, way or park for public uses. 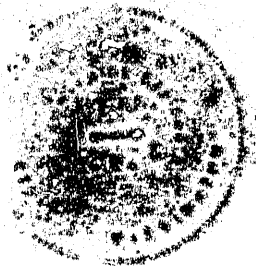
