CONUMIONS OF APPROVAL

The following conditions are required to ensure that the subject request is consistent with Skamania County Title 22. This document, outlining the conditions of approval, must be recorded in the deed records of the Skamania County Auditor in order to ensure notice of the conditions of approval to successors in interest. SCC §22.06.050(C)(2).

- 1) Fire Safety uidelines.
 - All buildings shall be surrounded by a maintained fuel break of 50 feet. Indigated or fire resistant vegetation may be planted within the fuel brokk, including green lawns and low shrubs (less than 24 linches in height). These should be placed greater than 15 feet between the crown and pruned to remove dead and low (less than 8 feet) branches. Aroumulated leaves, needles and other dead vegetation shall be removed from benitath trees.

- b) Hazardous fuels shall be removed within the fuel break area.
- Buildings with plumbed water systems shall install at least one standpips at a minimum of 50 fest from the structure(s).
- d) A privid, stream, tank or sump with storage of not less than 1,000 gallons, or a well or water system capable of delivering 20 gallons per minute shall be provided. If a well pump is located on-site, the electrical service shall be separate from the dwelling.
- Access drives shall be constructed to a minimum of 12 feet in width and not exceed a grade of 12 percent. Turnouts shall be provided at a minimum of every 500 feet. Access drives shall be maintained to a level that is passable to fire equipment.
- f) Within one year of the occupancy of a dwelling, the Department shall conduct a review of the development to assure compliance with this section.
- g; Telephone and power supply shall be underground whenever possible.
- h) Roofs of structures should be made of fire-resistent materials, such as metal, fiberglass shingle or tile. Roof materials such as cedar shake and shingle should not be used.
- i) Any chimney or stovepipe on any structure for use with a woodstove or fireplace should be screened with no coarser than 1/4 inch mesh metal screen that is noncombustible and corrosion resistant and should be equipped with a spark arrestor.
- j) All structural projections such as balconies, decks and roof gables should be built with fire resistant materials equivalent to that opecified in the Uniform Building code.
- k) Attic openings, soffit vents, foundation louvers or other ventilation openings on dwellings and accessory structures should be screened with no coarser than 1/4 inch mesh metal screen that is noncombustible and corrosion resistant.
- 2) The residence shall be set back at least 200 feet from the southern parcel boundary.
- 3) Except those which are necessary for construction purposes, all existing oak and confier trees shall be retained and maintained in a healthy condition.

- All oak and conifer trees that should die or are otherwise damaged, including those which are necessary for construction purposes, shall be replaced in kind.
- 5) The following procedures shall be effected when cultural courses are discovered during construction activities.
 - a) Hait Construction. All construction activities within 100 feet of the discovered cultural resource shall cease. The cultural resources shall remain as found; further disturbance is prohibited.
 - b) Notification. The project applicant shall notify the Planning Department and the Gorge Commission within 24 hours of the discovery. If the cultural resources are prehistoric or otherwise associated with Native Americans, the project applicant shall also notify the Indian tribal governments within 24 hours.
 - c) Survey and Evaluations. The Gorge Commission shall arrange for the cultural resources turvey.

NOTES

Any new residential development, related accessory structures such as garages or workshops, and additions or alterations not included in the approved site plan, will require a new application and review.

An per SCC §22.06.050(C)(2), the Director's Decision shall be recorded in the County deed records prior to commencement of the approved project.

As per SCC §22.0(.050(C)(5), the decision of the Director approving a proposed development action shall become void in two years if the development is not communiced within that period, or when the development action is discontinued for any reason for one continuors year or more.
