PARCEL 1

A tract of land located in the Northwest Quarter of the Northeast Quarter of Section 29, Township 3 North, Range B East of the Willamette Meridian, in the County of Skamania, State of Washington described as follows:

Beginning at a point 25 feet West of the Northwest corner of Lot 5 of Block 4 of BOYD AND WILKINSON'S ADDITION to Carson, according to the official Plat thereof on file and of record in the office of the Auditor of Skamania County, Washington; thence East 325 feet, more or less, to intersection with the East line of the Northwest Quarter of the Northeast Quarter of the said Section C3; thence South to the Northerly line of the 300 foot strip of land acquired by the United States of America for the Bonneville Power Administration's electric power transmission lines; thence Westerly following the North line of said strip of land 325 feet, more or less, to a point due South of the point of beginning; thence North to the point of beginning.
