CONDITIONS OF APPROVAL:

The following conditions are required to ensure that the subject request is consistent with Skamania County Title 22. This document, outlining the conditions of approval, must be recorded in the deed records of the Skamania County Auditor in order to ensure notice of the conditions of approval to successors in interest. SCC §22.06.050(C)(2).

- The exteriors of the footbridge and residence, including the roof and trim, must be finished in dark and either natural or earth-tone colors. The applicant shall submit color samples to the Department prior to issuance of a building permit.
- No portion of the residence shall be located within 100 feet of the ordinary high water mark of the normal pool elevation of the Columbia River.
- Except for the coniferous tree specified in the Staff Report, all existing screening shall 3) be retained and maintained in a healthy condition. Any tree that should die or is otherwise damaged shall be replaced in kind.

- 4) The height of the residence shall not exceed 30 feet above finished grade.
- 5) All exterior lighting shall be directed downward and sited, hooded and shielded such that it is not highly visible from key viewing areas. Shielding and hooding materials shall be composed of non-reflective, opaque materials.
- 6) The following procedures shall be effected when cultural resources are discovered during constructir n activities.
 - a) Halt Construction. All construction activities within 100 feet of the discovered cultural resource shall cease. The cultural resources shall remain as found; further disturbance is prohibited.
 - b) Notification. The project applicant shall notify the Planning Department and the Gorge Commission within 24 hours of the discovery. If the cultural resources are prehistoric or otherwise associated with Native Americans, the project applicant shall also notify the Indian tribal governments within 24 hours.
 - c) Survey and Evaluations. The Gorge Commission shall arrange for the cultural resources survey.

Any new residential development, related accessory structures such as garages or workshops, and additions or alterations not included in this approved site plan, will require a new application and review.

As per SCC §22.06.050(C)(2), the Director's Decision shall be recorded in the County deed records prior to commencement of the approved project.

As per SCC §22.06.050(C)(5), the decision of the Director approving a proposed development action shall become void in two years if the development is not commenced within that period, or when the development action is discontinued for any reason for one continuous year or more.
