Dear Linda:

On February 13, 1996, you contacted Melissa Carlson-Price of the Board of County Commissioners to request that the County subordinate its security interest in the ambulance hall located on First Street.

Section 14 of the Real Estate Contract prohibits the sale of the property or any interest therein without the prior written consent of the seller, Skamania County. Therefore, you are prohibited from granting a lien on the property without the prior written consent of Skamania County.

The Board has considered your request and has agreed to permit the Skamania County Hospital District to grant 1st Independent Bank a security interest in the property.
