The final report and petition for distribution of Robert R. Walker, R. Orval Dreisbach and Thomas B. Foster, executors of the estate of R. E. Rogers, deceased, together with the supplemental final report and account of said executors and the report of Chester C. Adair as guardian ad litem, came on regularly for hearing this day before the undersigned judge of the above entitled court sitting in probate, the executors appearing by Foster, Pepper & Riviera, their attorneys, and the minor issue, born and unborn, of Stuart E. Rogers, including Robert Edward Rogers, appearing by their duly appointed, qualified and acting guardian ad litem, Chester C. Adair.

Proof was made to the satisfaction of the court and the court now finds and adjudges:

1. Notice of hearing final report and petition for distribution has been given in the manner and for the time required by law, namely, (a) by publishing once in the Daily Journal of Commerce, a legal daily newspaper printed and published in King County, Washington and of general circulation therein, more than twenty days preceding said hearing, which said hearing was assigned for June 18, 1975 at the hour of 10:00 o'clock a. m., and by order

1 of the court entered herein on said date continued to June 30,
2 1975, at the hour of 10:00 o'clock a. m., in the court room of the
3 probate department of said court, and (b) by causing to be mailed
4 more than twenty days before such hearing a copy of the notice of
5 the time and place fixed for said hearing to each heir, legatee,
6 devisee and distributee whose name and address are known to said ex-
7 ecutors, and proofs of publication and mailing are on file herein.

8 2. R. E. Rogers died testate in Seattle, Washington on
9 September 19, 1970, being at the time of his death a resident of
10 Seattle, King County, Washington and leaving estate subject to
11 administration in King County. His last will and testament, duly
12 executed by him in his lifetime, was duly admitted to probate here-
13 in on September 25, 1970. Under the terms of his will, Robert R.
14 Walker, R. Orval Dreisbach and Thomas B. Foster were named execu-
15 tors. Thereupon they duly qualified and since that time they have
16 been and now are the duly appointed, qualified and acting executors
17 of the estate of R. E. Rogers, deceased. Notice of their appoint-
18 ment and qualification as executors and therewith notice to the
19 creditors of R. E. Rogers, deceased has been published as required
20 by law and more than four months have passed since the date of
21 first publication. Written notice of their appointments and of the
22 pendency of the above entitled probate proceedings was mailed to
23 each heir, legatee, devisee and distributee whose name and address
24 were known to the executors, in the manner provided by law.

25 3. The final report and petition for distribution, filed
26 herein May 22, 1975, and the supplemental final report and account,
27 filed herein June 18, 1975, are in all respects true and correct
28 and supported by proper proof.

29 4. An inventory and appraisement of all of the estate of
30 the decedent which has come into the hands of the executors was
31 filed herein on November 30, 1971 and the appraisement of the
32 Final settlement and
decree of distribution

1 estate made by the appraiser duly appointed by the court shows the
2 value of decedent's estate to be \$666,499.44, increased for inher-
3 itance tax purposes to \$849,422.66. On October 9, 1970, upon the
4 application of the executors, the court entered an order herein
5 adjudging the estate of R. E. Rogers to be fully solvent.

6 5. On October 9, 1970, upon application of the executors,
7 the court entered its order directing the executors to pay out of
8 the principal of the estate to Gladys Deputy Rogers as a family
9 allowance the sum of \$1,500.00 from September 19, 1970, which
10 family allowance was continued by order of the court entered
11 March 17, 1971.

12 6. A federal estate tax return has been made to the United
13 States District Director of Internal Revenue and audited, the
14 federal estate tax in the sum of \$132,995.95 has been paid, and
15 the estate tax closing letter is on file herein.

16 7. An inheritance tax report has been made to the Inheri-
17 tance Tax Division of the Department of Revenue of the State of
18 Washington, inheritance tax in the sum of \$62,599.81 has been paid,
19 and the inheritance tax release (tax paid) is on file herein.

20 8. The claims presented against the estate have been paid
21 and satisfied.

22 9. The executors have accounted for all receipts and dis-
23 bursements, property disposed of, and property acquired, as set
24 forth in Exhibits "A", "B" and "C" attached to their final report
25 and account, filed herein May 22, 1975, and Schedule "A" on their
26 supplemental final report and account, filed herein June 18, 1975,
27 covering the period of administration to May 31, 1975, have paid
28 and satisfied for the account of the estate the claims of creditors
29 debts, the state inheritance tax, on account of the bequests, ex-
30 penses of administration, expenses of maintaining property of the
31 estate, investments and other expenses and costs incidental thereto,
32 final settlement and
decree of distribution -3-

1 the disbursements set forth in said Exhibits and Schedule, and have
 2 on hand the remaining cash and property of the estate (including
 3 reinvestments during administration) hereinafter described, sub-
 4 ject to distribution under the last will and testament of

5 R. E. Rogers, deceased.

6 10. R. E. Rogers left surviving him as his only heirs at
 7 law and next of kin his wife, Gladys Deputy Rogers, and his son,
 8 Stuart E. Rogers. Under the last will and testament of R. E. Rogers
 9 his estate is devised and bequeathed as follows:

10 (a) Unto his wife, Gladys Deputy Rogers, all of
 11 decedent's interest in their personal, usable effects, household
 12 furniture and furnishings and the like, one automobile of her
 13 choice, and their family home including the adjoining lots, more
 14 fully described as:

15 Lots 6, 7, 8, 19 and 20 in Block 1,
 16 Queen Anne Park Addition to the City
 17 of Seattle, according to plat there-
 18 of recorded in volume 28 of Plats,
 19 page 38, records of King County,
 20 Washington.

21 (b) Unto his son, Stuart E. Rogers, the balance of
 22 decedent's tangible personal property, including but not being
 23 limited to machinery, tools and equipment used in decedent's or
 24 decedent's and Stuart's building operations, subject to whatever
 25 encumbrances, as by way of purchase money, mortgage or conditional
 26 sale contract, existing at time of decedent's death.

27 (c) Unto Robert R. Walker, R. Orval Dreisbach and
 28 Thomas B. Foster, trustees of the marital trust under Section 2
 29 of Part First of decedent's will, the sum of \$100,000.00 for the
 30 benefit of Gladys Deputy Rogers.

31 (d) Unto Robert R. Walker, R. Orval Dreisbach and
 32 Thomas B. Foster, trustees of the residuary trust under Part Second
 33 of decedent's will, all of the rest, residue and remainder of
 34 Final settlement and
 35 decree of distribution

1 decedent's estate.

2 The executors have distributed the devise and bequests
3 described in subparagraphs (a) and (b) above, and on account of
4 the bequest described in subparagraph (d) above, and receipts
5 therefor are filed herewith.

6 On September 1, 1972, upon petition of the executors,
7 the court entered herein its order directing partial distribution
8 and termination of trust whereby the bequest described in subpara-
9 graph (c) above was satisfied and the marital trust was terminated.
10 The receipt of Gladys Deputy Rogers acknowledging full satisfaction
11 thereof was filed herein January 15, 1973.

12 11. In the state inheritance tax report and in the federal
13 estate tax return for the estate, the executor's fee of Robert R.
14 Walker was estimated and allowed as a deduction in the sum of
15 \$3500.00 (R. Orval Dreisbach and Thomas B. Foster, jointly and
16 severally, disclaiming any interest in said fee), which has been
17 paid and the fee of Foster, Pepper & Riviera as attorneys for the
18 executors and the estate was estimated and allowed as a deduction
19 in the sum of \$12,500.00 (on account of which the sum of
20 \$11,436.00 has been paid). The allowance of executor's fee and
21 attorneys' fee in the amounts of \$3500.00 and \$12,500.00, respec-
22 tively, would be just and reasonable.

23 12. This court has full and complete jurisdiction of the
24 estate of R. E. Rogers, deceased, and of all persons interested
25 therein.

26 13. The estate is ready for distribution.

27 Now, therefore, IT IS HEREBY ORDERED, ADJUDGED AND DECREED
28 that the acts and accounts of the executors and their final report
29 and account and their supplemental final report and account are and
30 each of them is hereby approved and allowed, and the court sets
31 over and distributes unto Robert B. Walker, R. Orval Dreisbach and
32 Final settlement and
