EXHIBIT "A"

The Southeast quarter of the Northwest quarter of Section 10 in Township 1 North, Range 5, East of the Willamette Meridian in the County of Skamania, State of Washington EXCEPTING THEREFROM the following described tract: Beginning at the intersection of the NEW CAPE HORN LANDING ROAD with the North line of State Road No. 8; thence following said North line of said State Road No. 8 Westerly to the East line of the OLD CAPE HORN LANDING ROAD; thence Northerly on said East line 200 feet; thence Easterly parallel with the North line of said State Road No. 8 to the West line of said NEW CAPE HORN LANDING ROAD; thence Southerly on said West line 200 feet more or less, to the North line of said State Road No. 8, being the point of beginning;

ALSO EXCEPTING: A tract of land beginning at a point 300 feet West of the center of Section 10, Township 1 North, Range 5, East of the Willamette Meridian on the South line of the Northwest quarter of said Section 10. Thence North 500 feet to the intersection with the South right of way line of CAPE HORN ROAD (County Road \$10050), as it existed on November 23, 1986. Thence following said right of way line West and South to the intersection with the South line of the Northwest quarter of Section 10, Township 1 North, Range 5 East of the Willamette Meridian; thence 825 feet East to the point of beginning.
