No member of either the Meyer/Attwell family or the Brown/Bucher family or any "friend" has any rights to trespass on the property or to possess or remove any item from the property without Ross C. Holden's written permission.

A written copy of the Last Will and Testament of Marcus Fremont and Wanda Chrystell Meyer is located in the top right file drawer, in the last bedroom/office, on the west side of the house and is also recorded in the Skamania County Clerk's Office, Skamania County, Washington.

In case of death or major life threatening emergency of Marcus Fremont and Wanda Chrystell Meyer we do give Ross Holden or his personal designee's permission to break the lock or to change the lock for his convenience on the entrance door and to have permission to be inside the house, garage or outbuildings.
