QUIT CLAIM DEED
 *With Boundary Line Adjustment

FOR THE PURPOSES OF ADJUSTING BOUNDARY LINES ONLY; John A. McGee and Naomi R. McGee, husband and wife, ("Grantor") hereby convey, release and quit claim to John A. McGee and Naomi R. McGee, husband and wife, ("Grantee") all of Grantor's right, title and interest to the following real property located in Skamania County, State of Washington:

Using the same True North bearings and reference points as described in the original deed to the Grantor, dated the 22nd day of August, 1969, and beginning at the Southeast Corner of the Jack Haffey 0.67 acre tract, said point being 2884.76 feet West and 1254.01 feet South of the Northeast Corner of Section 11, Township 1 North, Range 5 East of the Willamette Meridian; thence South 27°32' East 379.20 feet; thence North 55°59' East 124.0 feet; thence North 29°22' East 181.42 feet; thence North 73°30' West 382.8 feet to the point of beginning.

The above described tract of land shall accrue to the adjoining parcel to the West, becoming a part of the Truman tract (presently tax parcel 200), which is also presently owned by the grantees.

The purpose of this deed is to affect a boundary line adjustment between parcels of land owned by Grantor and Grantee; it is not intended to create a separate parcel, and is therefore exempt from the requirements of RCW 58.17 and Skamania County Short Plat Ordinance. The property described in this deed cannot be segregated and sold without conforming to the State of Washington and Skamania County Subdivision laws.

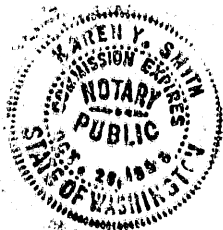
