PERSONAL REPRESENTATIVE'S DEED

Grantor hereby bargains, sells and conveys to DOUGLAS W. McCUISTION and DORIS L. McCUISTION, husband and wife, the following-described real property and improvements thereon situate in Skamania County, State of Washington, to-wit:
