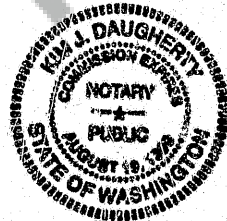

EXHIBIT A

A tract of land located in the Northeast Quarter of the Northwest Quarter of Section 8, Township 1 North, Range 5 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at an iron bar marking the intersection of the Westerly right of way line of County Road No. 1004, designated as the Bella Center Road, with the South line of the Northeast Quarter of the Northwest Quarter of the said Section 8, said point being 1,316.17 feet South and 181.99 feet West of the quarter corner on the North line of the said Section 8; thence North $80^{\circ} 12'$ West following the South line of the Northeast Quarter of the Northwest Quarter of the said Section 8 a distance of 705.58 feet to a point marked by an iron bar; thence North $04^{\circ} 47'$ West 136.14 feet to a point marked by an iron bar; thence North $76^{\circ} 51'$ East 222.60 feet to intersection with the Westerly right of way line of the Bella Center Road, said point being marked by an iron bar; thence following the Westerly right of way line of said road in a Southeasterly direction to the point of beginning.
