## PARCEL I

Lots 10 and 11 of IMAN ROCK CREEK TRACTS, according to the official plat thereof on file and of record in Book A of Plats, Page 118, Records of Skamania County, Washington.

## PARCEL II

That portion of the Northwest Quarter of the Southwest Quarter of Section 36, Township 3 North, Range 7 East of the Willamette Meridian, in Skamania County, Washington, described as follows:

Beginning at the Northeast corner of Lot 11, Iman Rock Creek Tracts, according to the official plat thereof, recorded in Book A of Plats, Page 118, Records of Skamania County, Washington, said point being 20 feet South of the South Bank of Rock Creek; thence Easterly parallel with and 20 feet Southerly from said South Bank, 70 feet; thence North parallel with the West line of said Northwest Quarter of the Southwest Quarter, 116 feet; thence West parallel with the North line of said Lot 11, a distance of 165 feet to the West line and along the most Northerly East line of Lot 10, of said West line and along the most Northerly East line of Lot 20 of said Iman Rock Creek Tracts, 131 feet to an inner corner of said Lot 10; thence Easterly, along the North line of said Lots 10 and 11, a distance of 110 feet to the point of beginning.
