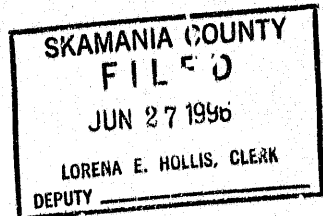

## II. ORDER

This matter came before the Court on May 16, 1996, upon motion by the plaintiff, Lee H. Smith, as Executor of the Estate of June Harris, Deceased, for entry of a money judgment against Mark A. Harris. The Court considered the default judgment entered against defendant Mark A. Harris on December 15, 1994. The amount of the judgment was not certain as of the date of entry and entry of a money judgment was reserved.

By the terms of the default judgment entered on said date, the defendant was ordered to pay to plaintiff, as executor, all funds belonging to the Estate of June Harris, Deceased, as shown by an accounting. The plaintiff, as executor of the Estate of June Harris, Deceased, was to have a money judgment against the defendant Mark A. Harris for the amount shown by such accounting to be due and owing to the Estate of June Harris, Deceased, which sums would be deemed to have been misappropriated by the defendant.

The defendant Mark A. Harris has failed to account for the following funds and the total thereof shall act as a money judgment against said defendant:

A. Disability proceeds:	\$2,868.00
B. Funds in unnamed trust account:	\$13,464.23
C. Unsubstantiated payments:	\$24,811.16
Total:	\$41,143.39

The Court finds the defendant held a fiduciary duty to June Harris as her attorney in fact and failed to meet said

1 duty by engaging in fraud through the misappropriation of the  
2 above-mentioned funds.


3 The Court having considered the pleadings filed in this

6 IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:


7 1. The plaintiff Lee H. Smith, as Executor of the Estate  
8 of June Harris, Deceased, shall have judgment against the defendant  
9 Mark A. Harris in the amount of \$41,143.39. Said judgment shall  
10 bear interest at the rate of twelve (12%) percent per annum  
11 until paid.

12 2. Plaintiff Lee H. Smith, as Executor of the Estate of  
13 June Harris, Deceased, shall have judgment against defendant  
14 Mark A. Harris in the amount of \$350.00 for a reasonable attorney's  
15 fee incurred in bringing this action.



