ORDER II. This matter came before the Court on May 16, 1996, upon 2 motion by the plaintiff, Lee H. Smith, as Executor of the Estate 3 of June Harris, Deceased, for entry of a money judgment against Mark A. Harris. The Court considered the default judgment entered against defendant Mark A.
