Fees will include a filling and application fee plus sales or use tax due. Additional fees may include: a filling allmination fee and a Mobile Home Affairs Fee, Subagents will charge an additional service fee, (Fees are subject to change without notice.)
- SECTION 4 Take the properly completed Manufactured Home Application and all necessary supporting documents to the County Auditor/Licensing Agent Office for approval. Supporting documents may include but are not limited to: proof of ownership or a Manufacturer's Statement of Grigin (MSO), proof of taxes paid, and applicable release(s) of interest. Subagents may not complete the approval portion of this form.
