**LIMITED POWER OF ATTORNEY**

1. The full or partial satisfaction/release of a mortgage or request to a trustee for a full or partial reconveyance of a deed of trust.
2. The modification of a mortgage or deed of trust.
3. The subordination of the lien of a mortgage or deed of trust.
4. The foreclosure completion of foreclosure, termination, cancellation or rescission of same relating to a mortgage or deed of trust, including, and/or but not limited to:
  - a. The substitution of trustee(s) serving under a deed of trust in accordance with state law and the deed of trust;
  - b. Statement of Breach of Non-performance;

  - e. Such other documents as may be necessary under the terms of the mortgage, deed of trust or state law to expeditiously complete said transactions.
5. The conveyance of properties or assignment of Mortgages, deeds of trust, and promissory notes to the Federal Housing Administration(FHA), the Veterans Administration(VA), or the Mortgage insurer(MI).

The undersigned gives to said Attorney-in-Fact full power and authority to execute such instruments and to do and perform all and every act and thing requisite, necessary and proper to carry into effect the power or powers granted by or under this Limited Power of Attorney as fully, to all intents and purposes, as the undersigned might or could do, and hereby ratify and confirm all that said Attorney-in-Fact shall lawfully do or cause to be done by authority hereof.
