I give all the rest and residue of my estate to my children as follows:

If the proceeds from the sale of the 8719 Bellevue property and the receipts from the mutual funds reaches a combined dollar value of over \$400,000 each of the five children, Karen, David, Rochelle, Dale and Ann, will each receive an equal share of \$80,000 from the first \$400,000.
