

IT IS HEREBY ORDERED that the Complaint of the Plaintiff shall be and is hereby dismissed as to Defendant Vern Veysey.


IT IS FURTHER ORDERED that Defendant Veysey shall be and is hereby awarded terms in the sum of \$500 - against the Plaintiff.

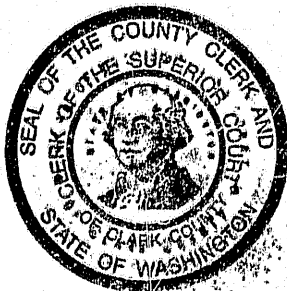
