reforestation land pursuant to Chapter 84.28 RCW. Timber land means the land only.

I/we declare that i am/we are aware of the liability of withdrawal or removal of this land from classification to the following extent:

- If the owner has filed the proper notice of request to withdraw the classified land and the land has been classified for a minimum of ten years he/she shall pay an amount equal to the difference between the tax computed on the basis of "current use" and the tax computed on the basis of true and fair value plus interest at the same statutory rate charged on delinquent property taxes.
