We reviewed your request dated April 2, 1997, for a Letter of Map Amendment. All required information for this request was received on September 15, 1997. Using the information submitted and the effective National Flood Insurance Program (NFIF) map, we determined portions of the property described below are in a Special Flood Hazard Area (SFHA), the area that would be inundated by the flood having a 1-percent chance of being equaled or exceeded in any given year (base flood); however, the structure on the property is not in the SFHA.
