A. CLASSIFICATION UNDER CHAPTER 84.34 RCW. I/we request that this land retain the current use classification as
Open Space Land,
Farm and Agricultural Land,
Timberland, and I am/we are aware of the following use classification of the land:

1. OPEN SPACE LAND MEANS EITHER:

- any land area so designated by an official comprehensive land use plan adopted by any city or county and zoned accordingly; or

- any land in contiguous ownership of twenty or more acres devoted: (i) primarily to the production

- b) DESIGNATED FOREST LAND is land that is primarily devoted to and used for growing and harvestisig timber but whose value for other purposes may be greater than its value for use as forest land.

I/we declare that \(\Gamma\) aware of the liability of removal of this land from classification or designation and upon removal a compensating tax shall be imposed that shall be equal to the difference between the amount of tax last levied on the land as forest land and an amount equal to the new assessed valuation of the land multiplied by the millage rate of the last levy extended against the land, multiplied by a number, not greater than ten, equal to the number of years the land was classified or designated as forest land.

- the sale or transfer of fee title to the parks and recreation commission for park and recreation purposes.
