Additional fees may include; a title elimination fee and a Mobile Home Affairs Fee. Subagents will charge an additional service fee. (Fees are subject to change without notice)
- Take the properly complete: Manufactured Home Application and all necessary supporting documents to the County Auditor/Licensing Agent Office for approval. Supporting documents may include but are not limited to: proof of own rehip or a Manufacturer's Statement of Origin (MSC), proof of taxes paid, and applicable release(s) of interest. Subagents may not complete the approval portion of this form. SECTION 4
