

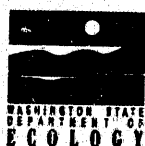

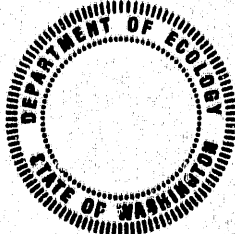
PROVISIONS
