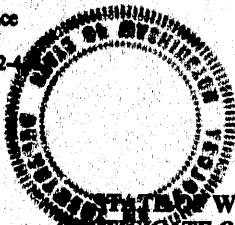

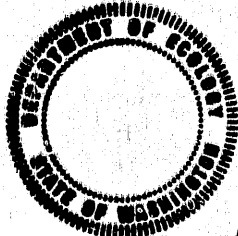
PROVISIONS
