CONDITIONS OF APPROVAL:

The following conditions are required to ensure that the subject request is consistent with Skamania County Title 22. This document, outlining the conditions of approval, must be recorded in the deed records of the Skamania County Auditor in order to ensure notice of the conditions of approval to successors in interest. SCC §22.06.050(C)(2).

- All developments shall be consistent with the enclosed site plan, unless modified by the following conditions of approval. If modified the site plan shall be consistent with the conditions of approval.
- 2) The pump station shall be finished in non-reflective materials of dark earth-tone colors, including doors. Applicant shall submit color samples to the department prior to issuance of a building permit to verify consistency with the above criteria.
- 3) Exterior lighting shall be directed downward and sited, hooded and shielded such that it is not highly visible from key viewing areas. Shielding and hooding materials shall be composed of non-reflective, opaque materials. All lights shall be hooded and shielded so as to have a luminary with less than a 90 degree cutoff. All lighting shall be limited to use on an as needed basis. Lights shall be turned on by a motion sensor or hand switch only. Permanent night lighting shall not be allowed.
- Applicant shall be required to plant a continuous row of screening trees on the south, west and east property lines, to be six feet tall at the time of planting and 12 foot on center. Existing trees may be utilized in the planting sequence. At least half of the trees shall be species native to the setting or commonly found in the area. Such species include fruit trees, maple and black locust. At least one quarter of any trees planted for screening shall be coniferous for winter screening. All screening trees shall be retained and maintained in a healthy state. Dead or dying trees shall be replaced in kind and in place.
- Applicant has completed the required reconnaissance survey. A copy of the final cultural resource reconnaissance survey shall be sent to SHPO and the Indian tribal governments with this Director's Decision. They shall have 30 days to submit written comments and/or give an intent to appeal to the Planning Department. During that 30 day time period, no ground disturbing activities shall occur on the subject parcel including the parcels addressed in the related Director's Decision NSA-97-04 for the walst tank. The project may commence after the 30 day time period if no written comments and/or the intent to appeal has not been given by the above mentioned agencies. If an appeal or comments are submitted, this approval shall be suspended until all conflicts and concerns are adequately addressed.
- Compliance to specific approval conditions shall be completed prior to operation.
- 7) The following procedures shall be effected when cultural resources are discovered during construction activities:

- a) Halt Construction. All construction activities within 100 feet of the discovered cultural resource shall cease. The cultural resources shall remain as found; further disturbance is prohibited.
- b) Notification. The project applicant shall notify the Planning Department and the Gerge Commission within 24 hours of the discovery. If the cultural resources are prehistoric or otherwise associated with Native Americans, the project applicant shall also notify the Indian tribal governments within 24 hours.
- Survey and Evaluations. The Gorge Commission shall arrange for the cultural resources survey.
