THE TRUST FOR PUBLIC LAND, a California non-profit public benefit corporation, Grantor, for and in consideration of ONE HUNDRED TWENTY THOUSAND DOLLARS (\$120,000) paid by Grantee pursuant to the Columbia River Gorge National Scenic Area Act of November 17, 1986 (P.L. 99-663), the receipt of which is hereby acknowledged, does hereby convey and warrant unto the UNITED STATES OF AMERICA, Grantee, and its assigns, all of the following described real property in the County of Skamania, State of Washington:

EXCEPT that part lying north of the south line of Strunk Road;

ALSO EXCEPT that portion conveyed to Skamania County by instrument dated April 30, 1981, and recorded June 29, 1981, in Book 79, Page 879;

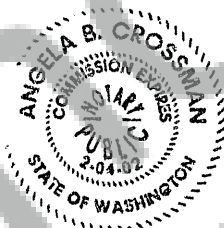
